WHAT ARE THEY? CRISIS PREGNANCY CENTERS GO BY SEVERAL DIFFERENT NAMES, LIKE "PREGNANCY RESOURCE CENTER" AND "PREGNANCY MEDICAL CLINIC," BUT THEY'RE ALL THE SAME THING: ANTI-ABORTION FAKE CLINICS THAT MISLEAD AND SHAME WOMEN SEEKING ABORTION CARE.





IN FACT, THEY ACTUALLY ARE OFTEN HIGHLY FUNDED, LITIGIOUS, AND PROVIDE INACCURATE INFORMATION. THEY MAY PRETEND TO **BE MOM-AND-POP OPERATIONS, BUT** BASED ON RIGOROUS RESEARCH MAINTAINED BY REPROACTION, MORE THAN 70 PERCENT OF THE FAKE CLINICS IN THE U.S. ARE AFFILIATED WITH LARGE NETWORKS WITH PLENTIFUL RESOURCES BEHIND THEM, PROTECTING AND ENHANCING THEIR EFFORTS TO STIGMATIZE AND DECEIVE PEOPLE THROUGH METICULOUSLY CRAFTED BRANDING AND ADVERTISING, IN STATE HOUSES AND COURTS, AND WITH THE HELP OF NUMEROUS PROMINENT CONSERVATIVE LEADERS.

THERE ARE ROUGHLY 2,700 IN THE UNITED STATES, MANY OF THEM MASQUERADING AS LOW BUDGET RESOURCE CENTERS WHERE KINDLY VOLUNTEERS PROVIDE MEDICAL HELP TO PEOPLE FACING UNEXPECTED



SEVERAL FAKE CLINIC NETWORKS, INCLUDING ONE IN CALIFORNIA, USED A TOOL THAT "GEOFENCED" WOMEN'S LOCATIONS, SENDING TARGETED ADS FOR AN ANTI-ABORTION FAKE CLINIC TO THE PHONES OF PEOPLE SITTING IN NEARBY ABORTION CLINIC WAITING ROOMS! [3]

STAFF AT FAKE CLINICS HAVE ALSO OUTRIGHT LIED ABOUT THE RISKS OF ABORTION, STATING THAT IT CAUSES BREAST CANCER, INFERTILITY, DRUG ABUSE, AND SUICIDE - ALL OF WHICH HAVE BEEN DISPROVEN TIME AND AGAIN BY MEDICAL PROFESSIONALS. THEIR CONTRACT WITH THE PA STATE GOVERNMENT IS STILL IN EFFECT, AND THEY OPERATE IN AND CONSULT IN OTHER **STATES**. [10]

WHILE MANY FAKE CLINICS RECEIVE HEFTY DONATIONS FROM PRIVATE ENTITIES, [2] TAXPAYERS SUBSIDIZE THEM AT A SHOCKING PRICE. SEVEN STATES – INDIANA, MICHIGAN, MISSOURI, NORTH DAKOTA, OHIO, PENNSYLVANIA, AND TEXAS - HAVE SIPHONED OFF \$30 MILLION IN FEDERAL TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) GRANTS OVER FOUR YEARS TO UNREGULATED, TAX-EXEMPT GROUPS. THAT MEANS WELFARE FUNDING INTENDED TO FEED HUNGRY CHILDREN GOES TO FAKE CLINICS THAT PROVIDE FLIMSY REASONS FOR THEIR USE OF FEDERAL MONEY, IF THEY JUSTIFY





## IN CONCLUSION:

NO MATTER WHAT YOUR POLITICS OR RELIGIOUS BELIEFS ARE, IT SHOULD BE A GIVEN THAT PEOPLE FACING IMPORTANT MEDICAL DECISIONS DESERVE ACCESS TO ACCURATE, UNBIASED, AND CONFIDENTIAL INFORMATION ABOUT THEIR HEALTHCARE, AND SHOULD KNOW IF THE PLACE THEY'RE SEEKING THAT CARE FROM ISN'T WHAT IT PRETENDS TO BE. FURTHERMORE. CENTERS THAT EXIST PURELY TO DISSUADE WOMEN FROM DECISIONS THEY HAVE ALREADY MADE FOR THEMSELVES AND THEIR FAMILIES SHOULD NOT RECEIVE TAXPAYER DOLLARS TO SHAME AND DECEIVE PEOPLE JUST BECAUSE THEY HAVE A BEEF WITH ABORTION.

## **Repraction**
